NORTH GRANVILLE WATER DISTRICT REPORT: The average usage per day was 56,064 per day or 1,681,920 for the month of January. A major water leak was found at an outside district customer. The customer drilled a well and is no longer using the system. The water tank is back up to 26 feet.
