HIGHWAY SUPERINTENDENT REPORT: Highway Superintendent Eric Towne reported that there have been 13 storms and 11 of them have been ice storms. The new truck, that has been ordered, will go into to production in March for delivery in May or June. A wood frame has been built on the box of the 91 sweeper dedicated for calcium. The DPW is cutting wood. More sand will be obtained tomorrow.

NORTH GRANVILLE WATER DISTRICT REPORT: The average usage per day was 47,580 per day or 1,475,000 for the month of January. The water tank is full and the pumps are off. The test results on the deep well are good. Councilman Quick inquired as to the possibility of drilling individual wells for the customers in the water district with a plan that the customer be charges an annual fee to cover the expense of the cost of drilling a well.
